This form is to be filled out by students receiving VA benefits for **EVERY** term they attend at the University of Mississippi (i.e. if you are taking classes over the Full Summer and classes in Second Summer you will need two separate TAFs).

Please **TYPE** this form. After you have typed it, please print it and bring to your Advisor. Have your Advisor **circle**, **initial**, and **sign** this form.

Please attach your **MyOleMiss Schedule** to this form so that we may confirm your courses.

Please turn in all paperwork **within the first week** of class to ensure timely processing from the VA.

If you add a course that is not on your TAF, you will be required to complete a new TAF containing all courses for that Term.

Should you drop a course after the drop date you will be responsible for any class fees or drop fees associated with that course.

If you have **changed your major**, please fill out the Change of Major Form. ([Link](#))

If you are doing **Study Abroad**, please contact veterans@olemiss.edu.

To have **minor** courses approved on the TAF, a minor must be required for your degree.

Failure to complete these and other requirements listed in the Statement of Understanding may result in dismissal of paperwork or processing delays.

In compliance with Mississippi Code, Title 97, Chapter 21, Article 1, Section 97-21-33 — penalty for forgery is the following: "Any person convicted of forgery when the amount of value involved is Five Thousand Dollars (\$5,000.00) or more, but less than Twenty-five Thousand Dollars (\$25,000) shall be imprisoned in the Penitentiary for a term not exceeding ten (10) years, or be fined not more than Ten Thousand Dollars (\$10,000.00), or both." **If you forge this or other VA paperwork, VMS will persue the maximum penalty.**
